Important Note...

Conversations with the advocate are confidential. Discussions with the advocate do not constitute making a report or filing a formal complaint. The advocate will not contact staff, parents, or others without the student's consent.

*Exceptions to confidentiality occur when there is imminent danger to self or others, if mandated reporting is needed for child, elder, or dependent adult abuse, or in rare legal circumstances.

Options

Survivors have multiple options such as:

What is Confidential Advocacy?

A SUPPORTIVE PLACE TO START

Confidential Advocacy brings a holistic approach to **supporting survivors**.

Advocates provide affirming, empowering, free, confidential support through a non-judgemental and compassionate approach to exploring all options, rights, and resources

HOW CAN WE HELP?

1:1 **confidential** crisis intervention, support, and safety planning

Trauma informed **validation** regarding common feelings and experiences

Survivor centered **healing** processes

Answers to questions regarding reporting

Accompaniments to protective orders, Title IX proceedings, medical forensic exams, law enforcement interviews, legal proceedings, etc.

Referrals for academic, administrative, and/or housing advocacy & community support services

Ongoing survivor **support**
